NOTIFICATION

Sub: Amendments to Ordinances

The following Amendments to the Ordinances and Appendices to the Ordinances of the University passed by the Executive Council at its meeting held on 19th July, 2014 are notified for information of all concerned:

- 1. Amendments to Ordinance II, Appendix II to Ordinance V(2) and VII, and to all other relevant Ordinances of the University, relating to the admission, revision of syllabi/scheme of examinations for LL.B. degree.(Page No. 270 & 325 of the University Calendar Volume I (2004) and 298 of University Calendar Volume II (1989)) (E.C. 19.7.2014).
 - I. Add the following Clause 12 to the Guidelines to the Ordinance II:
 - (12) Eligibility for admission:
 - (i) Three Year Law Degree Course: An applicant who has graduated in any discipline of knowledge from a University established by an Act of Parliament or by a State legislature or an equivalent national institution recognized as a deemed to be University or foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, may apply for a three years' degree programme in law leading to conferment of LL.B. degree on successful completion of the regular programme conducted by a University whose degree in law is recognized by the Bar Council of India for the purpose of enrolment.
 - (ii) Minimum marks in qualifying examination for admission.

The eligibility criteria for admission to LL.B. Degree course is as follows:-

- (i) For General candidates, Graduate/Post-Graduate Degree from the University of Delhi or any other Indian or Foreign University recognized as equivalent by the University of Delhi with at least 50% marks or an equivalent grade point in the aggregate in either of them.
- (ii) For other backward classes (OBC) candidates, Graduate/Post-Graduate Degree from the University of Delhi or any other Indian or Foreign University recognized as equivalent by the University of Delhi with at least 45% marks.





- (iii) For Scheduled Caste/Scheduled Tribe (SC/ST) candidates, a Graduate/Post-Graduate Degree from the University of Delhi or any other Indian or Foreign University recognized as equivalent by the University of Delhi with at least 40% marks. (As per Bar Council of India requirements).
- (iv) Relaxation of 5% marks in the minimum eligibility prescribed for general candidates will be allowed to widows/wards of ex-servicemen/serving personnel (CW) category.
- (v) Relaxation of up to 5% marks in the minimum eligibility prescribed for general candidates will be allowed to the candidates belonging to physically handicapped (PH) category on the recommendations of the Medical Board as per the prescribed procedure.

Provided that such a minimum qualifying marks shall not automatically entitle a person to get admission into an institution but only shall entitle the person concerned to fulfill other institutional criteria notified by the institution concerned or by the government concerned from time to time to apply for admission.

II. Replace the existing Clause 8 (a) of the Ordinance VII.2 of the Ordinances of the University with the following:

8(a) From the academic year 2014-2015, all the students of LL.B. shall have to put in minimum attendance of 70% of the lectures in each of the courses as also at the moot courts, tutorials and practical training course conducted or taught in a semester for taking the examination.

Provided that if a student for any exceptional reasons fails to attend 70% of the classes held in any subject or training course, the Dean of the Faculty of Law, may allow the student to take the Examination for the semester if the student concerned attended at least 65% of the classes held in the subject concerned and attended 70% of classes in all the subjects taken together in all the courses of the semester.

Provided further the Dean, Faculty of Law or a committee constituted by the Dean in this regard may relax absence from classes (of fifteen days in one semester and a maximum of twenty days in an academic year) for participating in recognized moot court competitions, seminars and conferences, legal aid camps and activities, sensitization programmes, permitted and approved internships, training programmes relevant to legal education, permitted attendance in court and for unforeseen circumstances.

The Dean of the Faculty or Professor-in-Charge of the Law Centre shall have power to strike off the name of a student who is grossly irregular in attendance in spite of warning, or, when the absence of student is for such a long period that he/she cannot put in requisite percentage of attendance for the semester.

Note: For the students already enrolled in any of the Centres or Faculty of Law before 2014-15 the present rules in clause 8 as prior to this amendment shall continue to govern their cases.





- 1. The Course for the Degree of Bachelor of Laws shall extend over a period of 3 academic years (i.e. six terms in all).
- 2. The medium of instruction shall be English. The medium of examination shall be English or Hindi.
- 3. Instruction shall also include Seminars, Tutorial Work, Moot Courts and Practical Training Programmes.
- 4. There shall be one examination at the end of each term, the academic year being divided into two terms as may be approved by the Academic Council from time to time. There shall be six terms in all.
- 5. The examination shall consist of one written examination at the end of each term in the courses prescribed. One paper shall be set in each of the courses prescribed for study, and the examination in a paper shall be of three hours' duration. All courses will have equal weightage.

Note: The amendment to the courses of study is to comply with the relevant rules of the Bar Council of India. The following shall be the subjects and courses of study for the examinations with effect from Academic Year 2014-15.

The syllabi of the papers already approved for the First Year under the existing courses shall be continue to be applicable for the papers in the First Year of the new course. The Faculty of Law shall seek approval of the syllabi for the additional papers prescribed in the Second and Third Years.

For the candidates admitted prior to Academic Year 2014-15, the existing course structure as applicable in II and III year will continue to apply.

Promotion Rules applicable to the LL.B. course in the Faculty of Law

- (i) No student shall be promoted to the next Term, if he/she has been detained in the examination for shortage of attendance.
- (ii) Subject to sub-rule (i) above, a student of LL.B. First, Third or Fifth Term shall be eligible for promotion to Second, Fourth or Sixth Term, respectively irrespective of the number of courses in which he/she has failed to pass or failed to appear in the First, Third or Fifth Term examinations.
- (iii) Subject to sub-rules (i) and (ii) above, a student of LL.B. Second Term shall be eligible for promotion to Third Term if he/she has passed in at least five papers of First and Second Term examinations taken together and a student of Fourth Term shall be eligible

for promotion to Fifth Term if he/she has passed in at least fifteen papers of First, Second, Third and Fourth Term examinations taken together.

Note: -The students eligible for admission to III/V Term must seek admission not later than two weeks from the date(s) of announcement of the results of LL.B. II/IV Term Annual Examinations or within one week of commencement of teaching, whichever is later, failing which they will forfeit their right to be admitted to III/V Term in the particular year.

Re-admission Rules

- (i) There shall be no re-admission in the LL.B. First Term under any circumstances including detention for shortage of attendance in that Term.
- (ii) A student who has been detained for shortage of attendance or for applying late for admission in Second, Third, Fourth, Fifth or Sixth Term shall be eligible for re-admission in the same Term in which he/she had been detained provided (a) he/she seeks readmission before commencement of teaching in the relevant Term; (b) his/her conduct has been satisfactory; and (c) he/she shows sufficient cause for his/her discontinuance of studies or for not having put in the requisite percentage of attendance to the satisfaction of a Committee consisting of the Dean, Faculty of Law and the Professors-in-Charge of the Law Centres.
- (iii) An applicant who has failed in examination or failed to appear at the examination and who is otherwise eligible to appear at the examination as an ex-student, shall not be admitted as a regular student. In exceptional cases, however, where such an applicant is a foreigner, studying under the Cultural Scholarship Scheme of the Government of India, etc., re-admission may be allowed.
- (iv) In respect of an applicant seeking re-admission, his previous record shall be carefully scrutinized at the concerned Law Centre.

Pass percentage and Classification of Successful Candidates

The following shall be the percentage of marks for passing the examination and for classification of successful candidates admitted to the LL.B. course:

- (i) A candidate must pass in all 30 courses in six Terms to be eligible to obtain the LL.B. Degree;
- (ii) A candidate must secure not less than 45% to pass in each Paper;
- (iii) A candidate securing 60% or more marks in the aggregate in all 30 courses taken together will be awarded First Division;



- (iv) A candidate securing less than 60% marks but not less than 50% marks in the aggregate in all the 30 courses taken together will be awarded Second Division;
- (v) No Division will be awarded to a candidate securing less than 50% marks in the aggregate in all the courses taken together;
- (vi) The Distinction in any paper(s) of a Term will be awarded only to those candidates who passed in all papers of the Term concerned in one attempt in normal course securing 75% marks in the paper(s) concerned.

Improvement of Previous Performance

- 1. A student studying in the Third Term may be permitted to surrender his/her result of any subject of the First Term within one month of the commencement of the Term provided:
 - a) he/she has passed that subject in the first attempt; and
 - b) at the time of surrendering his/her result, he/she has passed at least 5 other subjects of the First and Second Terms taken together excluding the subjects the result of which he/she wishes to surrender.
- 2. A student studying in the Fourth Term may be permitted to surrender his/her result of any subject of the Second Term within one month of the commencement of that Term provided:
 - a) he/she has passed that subject in the first attempt; and
 - b) at the time of surrendering his/her result, he/she has passed at least 5 other subjects of the First and Second Terms taken together excluding the subjects the result of which he/she wishes to surrender.
- 3. A student studying in the Fifth Term may be permitted to surrender his/her result of any subject of the Third Term within one month of the commencement of that Term provided:
 - a) he/she has passed that subject in the first attempt; and
 - b) at the time of surrendering his/her result, he/she has passed at least 15 other subjects of the First, Second, Third and Fourth Terms taken together excluding the subjects the result of which he/she wishes to surrender.
- 4. A student studying in the Sixth Term may be permitted to surrender his/her result of any subject of the Fourth Term within one month of the commencement of that Term provided:
 - a) he/she has passed that subject in the first attempt; and
 - b) at the time of surrendering his/her result, he/she has passed at least 15 other subjects of the First, Second, Third and Fourth Terms taken together excluding the subjects the result of which he/she wishes to surrender.
- 5. A student who has been promoted to the Sixth Term may be permitted to surrender the results of not more than two subjects of the Fifth Term within one month of the commencement of the Term or the publication of the result of the Fifth Term, whichever is later. In such a case, he/she will take the supplementary examination in those subjects to be held in that year subject to his/her being eligible for the benefit of supplementary examinations.
- 6. A student who has passed in all the subjects of the Sixth Term may, within one month of the declaration of the result of Sixth Term examination, surrender his/her result of not more than



two subjects of the Sixth Term along with a declaration that he/she will not seek enrolment or employment or any other benefit on the basis that he/she has passed the LL.B. examination till such time the result of the subjects in which he/she wishes to improve his/her performance has been declared. He/she will take the examination at the next available opportunity.

7. Such candidates who surrender results in order to improve their performance will take the examination in the current question paper based on the latest syllabus alongwith the regular students of that year.

Supplementary Examination

After the completion of six Terms, a student of LL.B. may take supplementary examination in any paper of I or III Term along with the V Term supplementary examination and in any paper of II or IV Term along with the VI Term supplementary examination held for the purpose: Provided that all the thirty papers required for getting the LL.B. Degree have to be cleared within the span period of six years.

Span Period

Subject to the provisions contained in the Ordinance relating to ex-students as in force from time to time, a student must clear all the courses offered in all the Terms within a span period of six years from the date of admission to first year of the LL.B. course. No student shall be admitted as a candidate for any LL.B. examination after six years from the date of admission to the first year of the course.


Scheme of Examination

The system of examination shall be as follows:

- (i) Excepting papers 237, 247 in MBA (IB) and 337 and 347 in MBA (HRD) each paper shall carry 100 marks of which 30 marks shall be reserved for internal assessment based on class room participation, seminar, term papers, study reports, tests, viva-voce and attendance. The weightage given to each of these factors shall be decided and announced at the beginning of the Semester. The remaining 70 marks in each paper shall be awarded on the basis of a written examination at the end of each semester. The duration of the written examination of each paper shall be three hours.
- (ii) Paper 237 and 337: Training Report: After the end of second semester, each student will go for summer training for a period of two months in a company. Immediately after the completion of the summer training, each student will submit a Training Report to the Department for evaluation in the beginning of the third semester. The evaluation of the Training Report shall be as follows:

Report evaluation -70 marks
Report presentation and viva-voce -30 marks

- (iii) Paper 247 and 347: Project Report : The scheme of evaluation for the Project Report shall be as follows:
 - (a) Project Report work shall begin from the third semester of Part II. Students shall select topic of their project work at the commencement of Semester III in consultation with the Faculty members. After approval of the project topics by the MBA (IB)/ MBA (HRD) Committee, they shall begin their work. At the completion of the project work, they shall submit three typed copies of their project report for evaluation before the commencement



(b) Based on the project work shall be a viva-voce examination at the end of Part-II and each candidate shall be evaluated out of 30 marks. The viva-voce examination shall be conducted by the internal and external examiners.

Evaluation and span period

(i) The minimum marks for passing the examination shall be 45% in each paper and 50% in the aggregate of the semester I, student fails to secure 45 percent marks in any of the papers, he/she can reappear in those paper/papers in the subsequent semesters.

If a candidate admitted to the examination in any semester secures the minimum marks to pass in each paper but fails to secure the minimum marks to pass in the aggregate, he/she may appear in any of the paper/s of the Semester concerned according to his/her choice in order to be able to secure the minimum marks prescribed to pass in the aggregate in each semester.

- (ii) If a student fails to appear in any of the papers in MBA (IB)/ MBA (HRD) Semester I of Part-I of the University examination, he/she will be allowed to take examination in that paper/papers along with second semester examination of Part I.
- (iii) Admission to Part-II of MBA (IB)/ MBA (HRD) Course shall be open to those who have cleared successfully at least 10 papers out of 14 papers offered for the MBA (IB)/ MBA (HRD) Part –I course comprising of Semesters I and II taken together. However, he/she would have to clear the remaining papers while studying in MBA (IB)/ MBA (HRD) Part II in the second year.
- (iv) If a student fails or fails to appear in any of the papers in third semester examination of Part-II other than Training Report, he/she will be allowed to take the examination in the subjects along with examination in the subjects of fourth semester of Part-II Examination.
- (v) Only those candidates who have secured at least 45 per cent in each paper and 50 percent in aggregate in each of the semesters of the MBA (IB)/ MBA (HRD) course shall be eligible for the award of the Degree. Successful candidates will be classified on the basis of the combined results of Part I and Part II examination as follows.

Candidates securing 60% and above : I Division
All others : II Division

- (vi) Candidates who have already received the minimum pass marks in the Training Report/Project report at the University examination shall not be allowed to reappear in the examination.
- (vii) The conditions of passing the course shall not be deemed to have been satisfied unless a student undergoes practical training under the supervision of the Department in approved organizations for at least two months.
- (viii) A candidate must qualify for the award of the Degree within four years of his/her admission to the MBA (IB)/ MBA (HRD) course.
- (ix) Candidates who fail or failed to appear the MBA (IB)/ MBA (HRD) examination after pursuing a regular course may be allowed to reappear at the examination on being enrolled as an ex-

- student as per the rules of the University. The old course will remain in force for ex-student only for a period of three years from the year in which the revised course introduced.
- (x) No candidate shall be considered to have pursued a regular course of study unless he/she is certified by the Department to have attended at least three-fourth of the total number of lectures, tutorials, special lectures and seminars conducted in each semester during his course of study. Provided that he/she fulfills other conditions, the Department may permit a student to proceed to the next semester who falls short of the required percentage of attendance by not more than 10% lectures, tutorials, special lectures and seminars conducted during the whole of that semester of the course but a student so permitted shall not be deemed to have completed a regular course of study in the next succeeding semester unless he/she makes up the shortage so condoned.
- (xi) No revaluation of answer books is permitted as per the rules of the University applicable to the professional courses.

At the completion of the project work, they shall submit three typed copies of their project report for evaluation before the commencement of the Semester - IV examination. Project report shall be a viva-voce examination at the end of Part-II and each candidate shall be evaluated out of 30 marks. The viva-voce examination shall be conducted by the internal and external examiners.
 - (b) Based on the project work shall be a viva-voce examination at the end of Part-II and each candidate shall be evaluated out of 30 marks. The viva-voce examination shall be conducted by the internal and external examiners.

Evaluation and span period

- (i) The minimum marks for passing the examination shall be 45% in each paper and 50% in the aggregate of the semester, student who fails to secure 45 percent marks in any of the papers; he/she can reappear in those paper/papers in the subsequent semesters.
 - If a candidate admitted to the examination in any semester secures the minimum marks to pass in each paper but fails to secure the minimum marks to pass in the aggregate, he/she may appear in any of the paper/s of the Semester concerned according to his/her choice in order to be able to secure the minimum marks prescribed to pass in the aggregate in each semester.
- (ii) If a student fails to appear in any of the papers in MBA (IB)/ MBA (HRD) Semester I of Part-I of the University examination, he/she will be allowed to take examination in that paper/papers along with second semester examination of Part -I.



- (iii) Admission to Part-II of MBA (IB)/ MBA (HRD) Course shall be open to those who have cleared successfully at least 10 papers out of 14 papers offered for the MBA (IB)/ MBA (HRD) Part –I course comprising of Semesters I and II taken together. However, he/she would have to clear the remaining papers while studying in MBA (IB)/ MBA (HRD) Part II in the second year.
- (iv) If a student fails or fails to appear in any of the papers in third semester examination of Part-II other than Training Report, he/she will be allowed to take the examination in the subjects along with examination in the subjects of fourth semester of Part-II Examination.
- (v) Only those candidates who have secured at least 45 per cent in each paper and 50 percent in aggregate in each of the semesters of the MBA (IB)/ MBA (HRD) course shall be eligible for the award of the Degree. Successful candidates will be classified on the basis of the combined results of Part I and Part II examination as follows.

Candidates securing 60% and above : I Division
All others : II Division

- (vi) Candidates who have already received the minimum pass marks in the Training Report/Project report at the University examination shall not be allowed to reappear in the examination.
- (vii) The conditions of passing the course shall not be deemed to have been satisfied unless a student undergoes practical training under the supervision of the Department in approved organizations for at least two months.
- (viii) A candidate must qualify for the award of the Degree within four years of his/her admission to the MBA (IB)/ MBA (HRD) course.
- (ix) Candidates who fail or failed to appear the MBA (IB)/ MBA (HRD) examination after pursuing a regular course may be allowed to reappear at the examination on being enrolled as an ex-student as per the rules of the University. The old course will remain in force for exstudent only for a period of three years from the year in which the revised course introduced.
- (x) No candidate shall be considered to have pursued a regular course of study unless he/she is certified by the Department to have attended at least three-fourth of the total number of lectures, tutorials, special lectures and seminars conducted in each semester during his course of study. Provided that he/she fulfills other conditions, the Department may permit a student to proceed to the next semester who falls short of the required percentage of attendance by not more than 10% lectures, tutorials, special lectures and seminars conducted during the whole of that semester of the course but a student so permitted shall not be deemed to have completed a regular course of study in the next succeeding semester unless he/she makes up the shortage so condoned.
- (xi) No revaluation of answer books is permitted as per the rules of the University applicable to the professional courses.

Teaching

The faculty of the Department is primarily responsible for organizing lecture work for M.Com. The instructions related to tutorials are provided by the respective registering units under the overall guidance of the Department. Faculty from some other Departments and constituent colleges are also associated with lecture and tutorial work in the Department.

Scheme of Examinations

- 1. English shall be the medium of instruction and examination.
- 2. Examinations shall be conducted at the end of each Semester as per the Academic Calendar notified by the University of Delhi.
- 3. The system of evaluation shall be as follows:
 - 3.1 Each paper will carry 100 marks, of which 30 marks shall be reserved for internal assessment based on a combination of tutorials, classroom participation, project work, seminar, term papers, tests, and attendance. The weightage given to each



- of these components in a combination shall be decided and announced at the beginning of the semester by the Department in consultation with the teachers. The system so decided will be communicated by the Department to respective colleges.
- 3.2 The remaining 70 marks in each paper shall be awarded on the basis of a written examination at the end of each semester. The duration of written examination for each paper shall be three hours.
- 4. Examinations for courses shall be conducted only in the respective odd and even Semesters as per the Scheme of Examinations. Regular as well as ex-students shall be permitted to appear/reappear/improve in courses of Odd Semesters only at the end of Odd Semester and courses of Even Semesters only at the end of Even Semesters.

Pass Percentage & Promotion Criteria

a. The minimum marks required to pass any paper in a semester shall be 40% in each paper and 40% in aggregate of a semester.

However, a candidate who has secured the minimum marks to pass in each paper but has not secured the minimum marks to pass in aggregate may reappear in any of the paper/s of his choice in the concerned semester in order to be able to secure the minimum marks prescribed to pass the semester in aggregate.

No student would be allowed to avail of more than 3 chances to pass any paper inclusive of first attempt.

- b. Semester to Semester Promotion: Students shall be required to fulfill the Part to Part promotion criteria. Within the same Part, students shall be allowed to be promoted from a semester to the next semester, provided he/she has passed at least half of the courses of the current semester.
 - **Part-I to Part-II Promotion:** Admission to Part-II of the Programme shall be open to only those students who have successfully passed at least 75% papers offered for the Part-I courses comprising of I and II Semester taken together. However, he/she will have to clear the remaining papers while studying in the 2nd year of the programme.
- c. Students who do not fulfill the promotion criteria (c) above shall be declared failed in the Part concerned. However, they shall have the option to retain the marks in the papers in which they have secured Pass marks as per Clause (a) above.
- d. A student who has to reappear in a paper prescribed for Semester I/III may do so only in the odd Semester examinations to be held in November/December. A student who has to reappear in a paper prescribed for Semester II/IV may do so only in the even Semester examinations to be held in April/May.



* Division Criteria

Successful candidates will be classified on the basis of the combined results of Part-I and Part-II examinations as follows:

Candidates securing 60% and above: I Division

Candidates securing 50% or more but less than 60%: II Division Candidates securing 40% or more but less than 50%: III Division

Span Period

No student shall be admitted as a candidate for the examination for any of the Parts/Semesters after the lapse of **four** years from the date of admission to the Part-I/Semester-I of the M. Com. Programme.

Attendance Requirement

Attendance in tutorials, seminars etc. arranged by the Department/ College from time to time, is mandatory according to the Internal Assessment requirement as per University rules.



Guidelines for Award of Internal Assessment Marks for the M.Com. course (Semester)

As per the decision of Department Council meeting held on 27th July, 2009, the following are the guidelines for the award of Internal Assessment marks to the students admitted to M.Com. Semester-based Course Scheme:-

- For each paper, there are 30 marks allocated for internal assessment and 70 marks for the Annual Examination. Out of 30 marks allocated for internal assessment for each paper:
 - 20 marks are to be assigned for class test
 - 5 marks are to be assigned for assignment
 - 5 marks are to be assigned for attendance
- ❖ A class test of 20 marks in each paper will be conducted by the teachers teaching the paper at the Department of Commerce. The date and time of the class test will be notified to the students by the respective teachers-in-charge of (M.Com) course at the Department of Commerce.
- * Five marks are to be awarded for assignment based work by the college/institution where the students are enrolled. The marks to be awarded on the basis of student's performance in any one or combination of assignments/activities such as presentation, participation in seminar/workshop, case study discussion, and submission of written assignments as part of their continuous evaluation. The composition of assignments/activities for each paper will be decided by the concerned college/ institution in advance and will be notified to the students.
- Five marks are to be awarded for attendance in the assignment/activities mentioned above by the college/institution where students are enrolled. The marks shall be awarded on the basis of existing norms for award of marks for attendance as per the Internal Assessment Scheme of University. The marks for attendance shall be as follows:

(i)	More than 67% but less than 70%	1 Marks
(ii)	70% or more but less than 75%	2 Marks
(iii)	75% or more but less than 80%	3 Marks
(iv)	80% or more but less than 85%	4 Marks
(v)	85% and above	5 Marks

- - 2. A student who does not satisfy the criteria (1) above in any paper shall have to repeat the paper. The student shall be awarded ER (Essential Repeat) in that paper.
 - 3. A student who has to reappear in any paper of Semester I/ III/ V/ VII may do so only in the subsequent semester examination of Semester I/ III/ V/ VII respectively. Similarly if a student has to reappear in any paper of Semester II/ IV/ VI may do so only in the subsequent semester examination for Semester II/ IV/ VI respectively.
 - 4. A student who reappears in any paper (theory or practical) shall carry forward the marks of the internal assessment originally awarded to him/her.
 - 5. Total credit in eight semesters is 256. A student passing a paper will earn the total credit assigned to that paper.
 - 6. A student shall be eligible for promotion from 1st year to the 2nd year if he/she accrues at least 50% of the total credits in Semester I and Semester II combined. Similarly a student shall be eligible for promotion form 2nd year to the 3rd year if he/she accrues at least 50% of the total credits in Semester III and Semester IV combined (irrespective of the result at the end of the first year). A student shall be eligible for promotion from 3rd year to the 4th year if he/she accrues at least 50% of the total credits in Semester V and Semester VI combined (irrespective of the result at the end of the second year). A student shall be eligible to have passed the 4th year provided he/she earns 256 credits during Semester I to Semester VIII.
 - 7. No student will be held back in Semester I/ III/ V/ VII.
 - 8. A student who does not satisfy criterion (6) is required to repeat a year. However, he/she can retain the marks of all or some of the papers that do not carry an ER.

SPAN PERIOD

The span period to complete the course shall be six years from the year of admission.

ATTENDANCE

Averaged percentage of attendance to appear in the end semester examination shall be as per University Rules for Undergraduate Degree Examinations at the time.

EVALUATION

- a. The evaluation or assessment for each theory paper with 4 credits shall be based on regular internal assessment throughout the semester (25 marks), a semester long innovation project in the field (25 marks, evaluated as part of the end semester examination) and a final end-semester written examination (50 marks).
- b. The evaluation or assessment for each theory paper with 3 credits shall be based on regular internal assessment throughout the semester (20 marks), and a final end-semester written examination (55 marks).



- c. The evaluation or assessment for each theory paper with 2 credits shall be based on regular internal assessment throughout the semester (15 marks), and a final end-semester written examination (35 marks).
- d. The evaluation or assessment for a laboratory paper with 3 credits shall be based on regular internal assessment throughout the semester (45 marks for laboratory activities and 30 marks for the innovation project).
- e. The evaluation or assessment for a laboratory paper with 4 credits shall be based on regular internal assessment throughout the semester (60 marks for laboratory activities and 40 marks for the innovation project).
- f. For the project work or internship carried out either during the semester or during the summer break (Semester III Semester VIII), broad guidelines for the evaluation shall be as follows:


I. Evaluation of projects/ Internship with 6 Credits.

- (i) A candidate/group of candidates will be mentored by a teacher OR a responsible person in industry/organisation as assigned by the Programme Coordinator. On completion of the project, the students will submit a brief written report to the ERC. The report will be examined by a board of examiners (one board for 10 students), consisting of three members appointed by the Director, CIC on the recommendation of ERC.
- (ii) The evaluation will be on the work carried out by the student, written report and viva/ presentation. 60% weightage (90 marks) will be given to the continuous performance (by the mentor) and 40% weightage (60 marks) for the final assessment (by the board of examiners) after the completion of the project.

II. Evaluation of 32 Credits Industrial Internship/ Major Project (Semester-VIII)

A dissertation should be submitted at the end of VIII semester. However, ERC may grant extension, not exceeding the maximum duration of the semester but not more than six months at a time. The dissertation will be examined by a board of three members appointed by the Director, CIC on the recommendation of the ERC. A viva-voce examination will be conducted by the board and marks awarded taking into consideration both dissertation and viva.

The objective of the course is to provide the student paradigms of holistic learning, critical sensibility and the art of writing. Students will be encouraged to study courses that sensitize them to issues of social justice and public ethics.

Stream 2: Historical Tourism

Indian's rich heritage of history and culture attracts tourists in large numbers but is well known that the quality of information and tour services are deficient for the mid-level traveler in the country. Domestic tourism is on the rise, and here also the demand is for affordable quality and reliable guidance to historical sites.

"Historical Tourism" serves several purposes in making a student aware of the historical contexts in which modern society is embedded, in granting capabilities which open careers in a growth sector, and in encouraging self-employment in the hospitality industry. The University of Delhi offers a course in History (Hons.) at 21 colleges but the papers are not related to tourism. On the other hand a B.A Vocational Course in 'Tourism Management' does not enter the subject of History in depth. Combining the courses, and adding or modifying the course design through induction of papers in Sociology, Economics, Political Science, Languages and Art would enhance the learner's capabilities for functioning effectively in the travel industry. Technology is an indispensable aid to the new competence required for simulations, photography, digitization, data analysis as a part of understanding the historical frameworks of modern India.

Stream 3: Counseling

Counselors are employed in government and public schools. There is an acute shortage of trained counselors. Without appropriate preparation, training and practice adequate justice cannot be done to any assignment in this area. Seeing how vulnerable the recipient of counseling is, an important social responsibility lies in creating a cadre of qualified personnel who will attempt to impart holistic guidance, especially to school children and young adults in college.

In this context the stream "counseling" offered in this programme is extremely relevant to the present day society in India. While the programmes of 'Psychology' and 'Applied Psychology' are offered at the University of Delhi, this programme is different because it offers a holistic knowledge through also offering subjects in Sociology, Literature, Art, Music etc. to establish competencies that are interdisciplinary and innovative. Counseling may take the form of therapy through Arts, or confidence building through Personality Development, or advising on subject choice through an assessment of aptitude etc.

The stream "Counseling" is not replicating the Psychology Honours programme but it is setting up the frame for additional explorations.

Stream 4: Art & Design

This stream creates an opportunity for interdisciplinary learning that recognizes the link between creativity and technology. The disciplinary boundaries of traditional universities have created gaps between those who have an aptitude for designing, painting, visual communication and those with talent for the applications of high-end technology. The entrepreneurial management of the arts has opened another field where Art and Business combines successfully. Given the work environment today and the demand for soft skills in market driven conditions, professional openings are available in art galleries, craftwork, book publishing, exhibition curating, apparel design and many other avenues. Those who have ICT capabilities are at an advantage.

While this stream may lead to jobs related to Museology and art management, those interested in design will get grounding for jobs in the burgeoning fields of Fashion Design, Interior Design, and furniture Design etc. Computer aided design is quite the norm today but traditional courses do not lay sufficient emphasis on this aspect.

Joint Degree of DU & JMI:

On successful completion of the program, joint degree will be awarded to students enrolled in Meta University concept course M.Sc. (Mathematics Education). The joint degree shall carry the logo and signatures of competent authorities of both DU and JMI. The degree shall be in three languages: English, Hindi and Urdu.

Coordination Committee for M.Sc. (Mathematics Education):

As per UGC guidelines, there shall be a coordination committee constituted by participating universities for each Programme. The participating Universities shall be responsible for deciding

- (a) Duration of Programme.
- (b) Number of course required for the programme.
- (c) Fee structure for the programme.



Promotion Scheme for M.Sc. (Mathematics Education)

(i) General Rules:

- 1. A student shall earn full credits for a paper if she/he passes the paper and shall earn no credit if she/he fails in the paper.
- 2. All students shall be promoted from first to second semester irrespective of their performance in first semester. Similarly, all students shall be promoted from third to fourth semester irrespective of their performance in third semester.
- 3. A student shall be eligible for promotion from 1st year to 2nd year (third semester) provided she/he has passed five out of ten papers. (i.e. minimum 50% of the papers)



- 4. A student not eligible for promotion from 1st year to 2nd year (third semester), however, shall retain her/his marks secured in papers she/he passed and that of Internal assessment only in papers she/he has not passed.
- 5. If a student fails in an Innovation Project paper, she/he has to either redo the project or carry out a new project.
- 6. A student will be given a maximum of three chances in total to pass a paper as and when that paper's examination takes place within three years of his first appearance in the examination of that paper.
- 7. No supplementary examination shall be conducted.
- 8. A student shall be awarded the degree only if he/she passes in all the papers.
- 9. Grand Total of marks of all four semesters is 2800. A student shall be awarded first division if she/he secures 60% or more marks in aggregate. A student shall be awarded second division if she/he secures marks between 50% or more marks but less than 60% in aggregate. A student shall be awarded third division if she/he secures marks between 40% or more marks but less than 50% aggregate.

(ii) Reappearance in passed papers:

- 1. A student may reappear in any theory paper prescribed for a semester, on foregoing in writing her/his previous performance in the paper/s concerned. This can be done in the immediate subsequent semester examination only. The result for this paper will be revised incorporating current performance.
- 2. In the case of a candidate, who opts to re-appear in any paper/s under the aforesaid provisions on surrendering her/his earlier performance, but fails to reappear in the paper/s concerned, the marks previously secured by the candidate in the paper/s in which she/he has failed to re-appear shall be taken into account while determining her/his result of the examination held currently.
- 3. A student who reappears in a theory paper shall carry forward the internal assessment and project/practical marks, originally awarded in that paper.
- 4. Reappearance in a passed Innovation project paper shall not be allowed.

(iii) Attendance Requirements

- 1. For papers studied at University of Delhi, student shall have to fulfill the attendance rules of University of Delhi.
- 2. For papers studied at Jamia Milia Islamia, student shall have to fulfill the attendance rules of Jamia Milia Islamia
