- 5. The service provider awarded the work shall not sub contract, fully or partially catering service to any other person/persons or agency.
- 6. The food supplied should conform to all the standards fixed by the statutory/ governmental authority of both state and/ or central and for any infringement of these standards the contractor shall be responsible wholly and solely for the purpose and the institute will have no responsibility of any kind in this regards.
- 7. It shall be the duty and responsibility of the service provider to ensure that the employees engaged for the work are physically fit and free from all communicable contagious, infectious and other diseases. If any employee(s) is/ are found to be suffering from any disease or if any employee (s) commit any misconduct or misbehavior, the service provider shall be required to remove such employee (s) immediately.
