## PROFESSOR M.S.A. RAO MEMO'RIAL MERIT SCHOLARSHIPS

There shall be two scholarships called 'Professor M.S.A. Rao Memorial Merit Scholarship' of the value of Rs. 250/-p.m. each payable out of the annual income accuring from the interest on the 'Brofess'r M.S.A. Rao Memorial Fund-I of Rs.53,000/- endowed to the University by the Professor M.S.A. Rao Memorial Committee.

2. The Scholarships shall be awarded to two deserving students of M.A. Part-II course in Sociology enrolled at the Delhi School of Economics.

- 3. The Scholarships shall be awarded on the recommendation of the Scholarships Committee of the Department of Sociology which will follow the same procedure of selection as is followed for the award of other merit based scholarships with the Department.
- 4. The Scholarships shall be awarded every and shall be tenable for 10 months only from 1st July of a academic year to 30th April of the same academic year (next calender year).
- 5. If it should appear at any time to the Head of the Department of Sociology that a scholer has failed to make satisfactor progress or has been guilty of gross misconduct, after due warning in writing, his cholarships may be suspended or with rawn on the specific recommendation of the Scholarships Committee of the Department of Sociology.
- 6. No student shall be eligible for this scholarship if he/she already holds a scholarship awarled by Delhi University or any other University or the Central Covernment or any State Covernment or a Private, Body.
- 7. In case a scholar under this end wment accepts any other scholarships /financial assistance from any other source, he/she shall be required to surrender this scholarship and shall be required to refund the amount received by him/her on account of this scholarship from the date he/she accepts the other scholarship/financial assistance.

- 8.) In case a scholar discontinues the studies without valid reasons, he shall be required to refund the amount received by him/her on account of the scholarship.
- 9. In case a scholarship falls vacant during the pendency of the same, it may be re-awarded to another student on the recommendations of the epartmental Scholarships Committee for the residuary period.
- 10. Any amount accruing from interest from the endowment and not spent in any year shall be added to the corpus of the endowment fund.
- The payment of the scholarship amount will be made to the scholar through the Head of the Department of Sociology on the presentation of a bill and a certificate to the effect that during the period covered in the bill, the scholar was not in receipt of any other scholarship or financial assistance from any other source and also that he/she was regular in attendance and his/her progress at studies was satisfactory.
