549/ The Council considered the following recommendations of the Academic Council made at its meeting held on 12th August, 1980:-

Ref: E.C. Resolution No. 181 dated 25.1.1945.

That the following amended provisions for the award of 'Puran Chand Khatri Sizarships', be accepted and forwarded to the Executive Council for approval:

## 'Puran Chand Khatri Sizarships!

There shall be two sizarships called 'Puran Chand Khatri Sizarship of the value of Rs.40/- each per mensem for award every year to the students who belong to Khatri families and are in the first year of the three-year-degree course. The Sizarships, tenable for a period of one year only, are awarded in order of merit on the basis of the result of the Senior School Certificate Examination (Class-12) of the Central Board of Secondary Education New Delhi or an examination recognised as equivalent thereto.

- NOTE: (1) The Executive Council at its meeting held on 25th January, 1945 had accepted the following recommendations of the Academic Council:
  - (a) That in view of the fact that the Intermediate Examination has been abolished, the Puran Chand Khatri Scholarships will hereafter be known as Sizarships and will be awarded for one year to the best Hindu Khatri students studying in the first year of the three-year Degree Course after having passed either the Higher Secondary Examination, Delhi, or the Qualifying Examination conducted by the University. The Selection will be made on the percentage of marks obtained by the candidates.
  - (b) That as the above mentioned endowment no longer provided the income to meet the present value of the Scholarships, the actual amount of income produced by the endowment fund be disbursed to the candidates.
    - (2) The minimum eligibility conditions for admission to the various Under-Graduate Degree Course in the University have been changed from Higher Secondary Examination of the Central Board of Secondary Education, New Delhi, to the Senior School Certificate Examination (Class-12) of the said Board from the Session 1979-80.
    - (3) The income from the endowment fund would be sufficient to meet the expenditure for the award of two sizarships of the value of Rs.40/- each per mensum for award every year.

## ' SATISH BATRA MEMORIAL SCHOLARSHIP'

There shall be a scholarship known as 'Satish Batra Memorial Scholarship' of the value of Rs.300 p.m. to be awarded out of the annual income accruing from the endowment fund of Rs.30,000/- endowed by Mrs. Trippta Batra,521, Sec. 16-A, Faridabad, wife of late Shri Satish Batra.

- The scholarship of the value of Rs. 300/-p.m. teneble for a period of three years shall be awarded to a needy student who have passed the Senior School Certificate Examination from the Central Board of Sc andary Education, New Delhi or an examination recognised as equivalent thereto, with 60% marks in Urdu and joins the Ist year B.A. (Hons.)/B.A. (Pass) with Urdu of this University.
- 3. The scholarship shall be tenable for a period of three years renewable yearly on the basis of satisffactory performance of the student at the previous year examination.
- (a) No student shall be eligible for the award of this scholarship if he or she already possesses a scholarship awarded by the University of Delhi or any other University or the Central Government or any State of India or a Private Body other than a free ship.
  - (b) In case a scholar under this endowment is awarded any other scholarship or gets finencial aid from any other sourcs, he/she shall be required to refund the amount received by him/her on this account from the data he/she was awarded any other scholarship or gets financial aid.
  - If it should appear at any time during the tenure of the award that the scholar has failed to make satisfactory progress or has been found guilty of gross missonduct or has been irregular in attendence, he/she shall, after due warning in writing, be reported by the Principal/Head of the Institution of his/her College to the Academic Council which may reduce, suspend or withdraw the scholarship.
  - 6. The scholarship shall be awarded by the Academic Council on the recommandations of a Selection Committee constituted as follows:
    - 1. The Dean, Faculty of Arts
    - 2. The Head, Department of Urdu.
- 7. The payment of the scholarship amount shall by made to the scholar through the Principal of his/her College on prosentations of a bill and a certificate to the effect that during the period covered in the bill the awards e was not in receipt of any other scholarship/financial assistance from any other source.
- 8. Any amount accruing as interest from the dadowment if not spent in any year shall be added to the corpus of the endowment fund.
- 9. A report of the award of scholarship will be furnished to the Donor.
