## " THE DELHI STATE COLOPERATIVE UNION STIPEND "

- Union Stipend' of the value of Rs.50/- per mensum, payable out of the annual income from the fixed Deposit with Dalhi State Co-operative Bank deposited in the name of the Vice-Chancellor, Dalhi University, by the Dalhi State Co-operative Union Ltd., for award to a student from among the sons/daughters or dependent brothers of non-commissioned defence force personnel resident of the Union Territory of Delhi who passed the Senior School Certificate Examination of the Central Board of Secondary Education, New Delhi or an examination recognised as equivalent therto and joins the 1st year of the three-year degree course of this University and is in need of financial assistance in pursuing his/her studies. Perference will be given to the son of a Jawan who was either killed or incapacitated during action against enemy in or after 1965.
  - (2) The stipend shall be tenable ordinarily for one year but may be renewed if the progress at studies of the scholar has been satisfactory.
  - (3) No student shall be eligible for this stipend if he or she already holds a scholarship awarded by the Delhi or any other University or the Contral Government or any State of India or a private body except free studentship.
  - (4) In case the scholar is awarded any other scholarship or gets financial aid from any other source the amount received by him/her from this scholarship shall be refunded by him/her to the University from the date he/she is awarded any other scholarship or gets financial aid.
  - (5) If it should appear at any time that a scholar has failed to make satisfactory progress or has been guilty of gross misconduct or laziness or has been irregular in attendance, he/she shall after due warning in writing, be reported by the Principal of his/her College to the Academic Council who may withdraw the stipend.
  - (6) Applications for stipend should meach the Registrar, giving detailed information on the prescribed form obtainable from the Registrar, University of Delhi, by the date mentioned in the notification issue in this respect by the Registrar.
  - (7) The stipend shall be awarded by the Academic Council on the recommendations of Committee to be appointed by the Vice-Chancellor of which the General Secretary, Delhi State Co-operative Union Ltd. shall be one of the members.
    - (8) The payment of the stipend amount will be made to the scholar through the Principal of his/her College on presentation of a bill and a certificate to the effect that during the period covered under the bill the scholar was not in receipt of any other financial assistance from any other source.
    - (9) In the event of there being no obligible student for award of the stipend, the interest accruing from the deposit shall be added to the corpus of the fund.
